Introduction

Warrnambool & District Community Hospice was formed in 2010 by a group of palliative care specialists and local people concerned by the number of people unnecessarily spending their final days in hospital and aged care. They identified a lack of social support as the key barrier to people dying well in their own home, and set about designing a free community service that would support informal care networks and fill gaps in local services.

When Hospice in the Home was launched in 2015, it gained attention from around the country for its innovative use of a volunteer workforce and flexible model of care. Today, the service is well established and working closely with local health and community services to support the provision of end-of-life care at home, and achieve our vision for a caring and compassionate community that facilitates the choice to die in the comfort of home.

Warrnambool & District Community Hospice Inc. is an incorporated association and charity registered with the Australian Charities and Not for Profits Commission. The organisation is endorsed as a Deductible Gift Recipient (DGR) and Public Benevolent Institution (PBI) with tax exempt status.

This Annual Report presents a wonderful opportunity to share our achievements with the community and acknowledgement the valued contributions of volunteers, staff, Committee members, financial supporters and advocates for our work.

Service Overview

Hospice in the Home is a free community service supporting the provision of end-of-life care at home in Warrnambool and surrounding areas within the Moyne and Corangamite Shires. It is an innovative model, where specially trained volunteers provide in-home support to people with a terminal or life-limiting illness, and their unpaid care givers.

Hospice in the Home complements the clinical care provided by the Community Palliative Care team at South West Healthcare. It also fills gaps in local healthcare and community services to ensure people who are dying, and their families, are able to live as well as possible, for as long as possible.

The service is designed to be flexible and responsive to the needs of care givers and recipients, and provide adequate social support to prevent carer burnout and unnecessary admissions to hospital and aged care.

Hospice in the Home is funded through the generosity of the community, and multi-year grants provided by the Department of Families Fairness and Housing, through the Support for Carers and Additional Respite programs.



2023/24 ACHIEVEMENTS



66 local people with a life limiting condition were supported to remain at home



85 local carers received respite and support



Hospice in the Home was powered by **2** part-time staff and **51** trained volunteers



A total of **1817** hours of respite and support were provided by staff and volunteers

Service Impact

In the 2023/24 Financial Year, Warrnambool & District Community Hospice assisted 66 people seeking endof-life care at home (6% more than in 2022/23). We also supported 85 of their family members, friends in the challenging role of Carer.

Our volunteers provided a total of 1431 hours of support in the home and community. The total number of hours was less than the 1805 previous year, most likely due to an increase in late referrals, and a number of people receiving support over weeks, rather than months. Encouraging earlier referrals is a key issue we are addressing.

The assistance provided through Hospice in the Home was tailored to the specific needs of each client and their family/carers and included supports such as.

- Respite for the primary carers to maintain their own wellbeing and responsibilities.
- Practical in-home support with hygiene, meals and daily household activities.
- Companionship and socialisation for the care recipient.
- Transport to shops, medical appointments and activities.
- Visits to clients in hospital or aged care.

An additional 386 hours of support was provided to primary carers by our staff as part of the referral process, rostering of volunteer support and follow up postbereavement.

After reaching a record high in 2022/23, the rate of people dying at home while receiving support through Hospice in the Home, dropped from 65% to 38%. This is partly to do with the increase in late referrals, which is also reflected in the large number of cases where the client died after assessment but before in-home support could commence.

It is important to note however, that statistics don't capture the quality or quantity of time our clients were able to have at home prior to being admitted to hospital or aged care, often out of necessity or by their own choice.

Information captured through our evaluation process would suggest that Hospice in the Home recipients and their caregivers receive significant benefit from accessing the program, even when an inpatient admission is the outcome.







Cuppa Club

Our monthly Cuppa Club is a valuable way to stay connected with the carers of deceased clients and support them in their grief and bereavement. This year, after feedback from participants, we extended membership to include carers of people currently receiving Hospice in the Home. The informal get-together at Hospice House is hosted by volunteers and attended by around 6-8 people each month who provide peer support to each other.

In October 2023 we were fortunate to secure a \$300 grant from Carers Victoria to host an event in Carers Week from the 15th to the 21st of October, 2023. Past and present carers were invited to afternoon tea at the Beach Kiosk in Warrnambool with staff members Leeona and Ann. Nine of our hardworking carers shared a relaxing afternoon tea, while the carers who could not make it received \$10 coffee vouchers.

We wish to thank Hospice volunteers Heather Heath and Lorraine Blake-Hoey for hosting the Cuppa Club and providing valuable support to people experiencing grief and disconnection from their usual social networks.

Service Feedback

Formal and informal feedback received from both clients and carers continues to be very positive. Hospice in the Home participants greatly value the support they receive from volunteers. They report that it helps relieve the practical and emotional burdens associated with caregiving, and it significantly contributes to preventing or delaying admission to inpatient care.

The hospice volunteers made an enormous positive difference in all of our lives. Mum was coping but also really struggling with the vague, uncertain experience of dad's slow (and then fast and then slow) decline.

The volunteers came over and talked with mum. And us. They provided the kind of social, relatable, normal (and normalizing) support that people should always have.

After dad died I spoke to (Support Coordinator) Ann on the phone for a LONG time. I described what happened and she really understood what I was going through. I am profoundly grateful for that talk.



Barry's Story

A Daughter's Perspective By Jenny Lukeis

Ten years ago, my darling Dad, Barry Brown, was diagnosed with Alzheimer's disease. Then on Mother's Day last year, came the news that he also had terminal pancreatic cancer. This diagnosis meant that my 80-year old Mum, Mary, who had been Dad's full-time carer for a long time, faced another challenging layer to her already huge caring role.

Dad relied on Mum for everything, not wanting her out of his sight. My sister, brother and myself tried to give Mum time out from caring for Dad, but found it hard with our jobs and visits limited to after work and weekends. We are so fortunate to have had Warrnambool & District Hospice and their Hospice in the Home program come to our rescue!

We were allocated a wonderful volunteer, Fred Chatfield who would take Dad out for adventures in the Hospice car, giving Mum time to herself to read a book, go for a drive on her own or get her hair cut. Seeing Fred would always put a smile on Dad's face. Having someone such as Fred willing to travel from Warrnambool to Camperdown to support our family and spend time with Dad is something we will never forget.

We also really appreciated the Hospice Support Coordinator, Ann Body, who would check in on Mum with regular phone calls and offer her support.

Dad passed away on November 7th last year (6 months to the date of his diagnosis) after an illness and short stay in hospital. Since then, we have run into Fred several times and talked about his time with Dad. It is lovely to be reminded of Dad and know that he is not forgotten.

My family are all very grateful to Warrnambool and District Community Hospice for sharing Fred with us during my Dad's illness last year, and for the support we received to keep Dad at home where he was comfortable and happy.

But at my first visit with him, we just

time to herself.

Barry and I would enjoy going out for lunch together at the Lake Purrumbete Café or Cobden Golf Club and taking the long way home. Spending time with Barry, I learnt about Slim Whitman music and his family's close association with footballer Adam Goodes and his family.

We loved to banter about his barracking for Richmond, even though he used to play music at every Geelong home game as a child. He claimed the Cats were no good and I would bite back, as every Geelong supporter would.

I was shocked when Barry died after only a few months of knowing him, and sad that we didn't get more time together. It was a great privilege for me to have helped a very nice family in a tough emotional time, and to be so appreciated by them.

Thanks Barry (aka The Clown) Brown and family, and thanks to Hospice for the opportunity to do something so meaningful and important in our community.

Our Volunteers

At Warrnambool & District Community Hospice we are exceptionally grateful for the compassionate volunteers who are the heart and soul of our organisation.

Volunteer Education & Engagement

Warrnambool & District Community
Hospice is committed to providing
education and engagement
opportunities that enhance knowledge,
confidence and skills of our volunteers
and contribute to a positive and fulfilling
volunteer experience.

In 2023/24, our Volunteer Education & Engagement Program was funded with a FRRR Strengthening Rural Communities Grant and Wannon Water Ripple Effect Grant. We thank both organisations for their assistance in providing our volunteers with valuable educational opportunities, particularly the workshops provided by acclaimed, Philip Island-based, Counsellor and Group Facilitator, Linda Wilson.

In March 2024, Linda Wilson brought her Accidental Counsellor Workshop to Warrnambool for a second year, and also ran a full-day session on Managing Stress & Building Resilience.

There were 13 people who participated in an Accidental Counsellor Workshop, and acquired techniques, tools, and strategies to successfully support people who are distressed, upset or requiring emotional support, within the context of professional boundaries.

A further 16 people participated in the Managing Stress workshop, which helped them to recognise and be mindful of their own stress levels and understand how stress physically affects the brain chemistry and function. They also took away practical ideas and techniques to assist in the management of stress in their lives, and volunteering role with Hospice.

Volunteers also participated in a visit to the Colac Hospice, Anam Cara House, a practical skills update session at Hospice House, tour of the new Hycel Technology Hub, and online training sessions offered through Palliative Care Victoria, Justice Connect and Our Community.

Volunteering Training

Our volunteer recruitment and training in 2024 was funded by generous support from the Rotary Club of Warrnambool & the East Warrnambool Football & Netball Club. These clubs have committed a total of \$15,000 per year over the next three years to ensure we can continue to attract, train and induct the volunteers that our Hospice in the Home service relies upon, and provide them with the skills to support the provision of end-of-life care at home. We thank them for their contribution and commitment to supporting their local community.

Recruitment commenced in late 2023 for the training program over four weeks in February and March, 2024. There were 12 new volunteers who completed the 24 hours of training and graduated at the Volunteer Meeting in March. Eight of these volunteers have since commenced active support with Hospice clients and carers.

Formal evaluation and informal feedback on the training course continued to be positive, with new volunteers feeling well- prepared and informed to commence in-home service.

We would like to acknowledge and thank the volunteers who trained our new recruits, Dr Eric Fairbank, Felicity Barker, Isobel Siebel, Pam Wines, and Sandy Westley.

We would also like to thank the Gardiner Dairy Foundation for their support which allowed us to host training at our headquarters, Hospice House, for the first time. The grant they provided through the Foundation for Rural and Regional Renewal enabled us to purchase a computer, data projector, whiteboard and accessories, which we are also using to take our volunteer recruitment, and community engagement sessions on the road, and into dairy farming communities in our service area.

Community Engagement

A major barrier to people dying well in their own homes is a lack of discussion and planning around end-of-life choices, and knowledge of the services available. As part of our commitment to support the provision of end-of-life care at home Warrnambool and District Community Hospice has pursued the following opportunities to engage with the community and promote our services.

Community Presentations

Staff, Volunteers and Committee of Management members gave a total of 14 presentations in 2023/24 to local service and sporting clubs, community groups and businesses about Hospice and the services it offers (including three outside of Warrnambool). The talks are a key component of our community engagement strategy that contribute to Hospice in the Home referrals, and the success of community fundraising efforts. We also provided three volunteering information sessions in Warrnambool & Camperdown.

Community Engagement

End of Life Preparation Workshops

Over 100 community members attended one of the 9 End of Life Preparation workshops at the Archie Graham Centre or additional workshops at Gillin Park, Anchor Point and Port Fairy Community House. We are very grateful to our Patron, Dr Eric Fairbank and committee member Lu Butler, for hosting the workshops and sharing their expertise for the benefit of the wider community.

Publicity

Hospice was featured several times throughout the year in the Warrnambool Standard, Warrnambool Weekly, Fitz Media Local News, and interviews on 3YB and 3WAY FM. Interviews focused on Volunteer Week, Palliative Care Week and Hospice events.

Social Media

Through regular social media engagement Hospice's social media following has grown over the last financial year from 105 to 137 followers on Instagram and from 790 to 860 followers on Facebook. The audience on Facebook is 88% women mostly aged 45+, with posts reaching a total of 21,217 people in 2023/24.

The Manual for Living & Dying in Style

As a service to the community, we publish "The Manual for Living & Dying in Style", written by our Patron Dr Eric Fairbank. It is an easy to read guide to ensuring our final wishes are met, and the people we love are taken care of. The book is provided free of charge to Hospice in the Home clients, participants in the End of Life Preparation Workshop and members of the community through aged care and retirement facilities in Warrnambool and surrounding areas. Copies are also available to purchase for \$5 at the Archie Graham Centre and various community events and expos.

Our Networks

Community Palliative Care

We work very closely with the Community Palliative Care team from Southwest Healthcare to provide coordinated support for people receiving palliative care at home, and their care givers. Our Support Coordinators are in weekly contact with Vikki Hoy, CPC Manager (acting) and Julie Evans, SWH Coordinator of Volunteers.

Palliative Care Victoria - Managers of Volunteers

This network meets monthly via Zoom to support Managers of volunteers and discuss information related to the successful recruiting, training, retention and recognition of palliative care volunteers. They also provide access to regular training sessions for Managers of Volunteers to ensure they have current information and knowledge of palliative care best practice.

South-West Volunteer Network

This group convened by the Warrnambool City Council and is a great way of information sharing as well as hearing from guest speakers. Meetings are held bi-monthly.

Leaders of Health Volunteer Engagement (LOHVE) Network

The LOHVE Network – meets monthly online and is a state-wide network for Managers of volunteers primarily from health services. It generously shares service information, research and suggestions for the successful delivery of volunteer services.

SWH Community Palliative Care Community of Practice

Representatives from the Community Palliative Care team from Southwest Healthcare, along with other local palliative care providers and stakeholders, meet quarterly to discuss and update any issues related to palliative care in the southwest region.



Financial Report


Income

As an organisation providing a free community service without recurrent government funding, Warrnambool & District Community Hospice must rely on a combination of government grants, philanthropic support and community fundraising to fund our operations.

We have been fortunate in recent years to secure multi-year support from the Victorian Government through the Department of Families Fairness & Housing' Support for Carers program. In 2023/24 we received a total of \$126,502 – including the second instalment of a four-year Support for Carers grant and the first instalment of a two-year commitment from the Additional Respite program.

Multi-year commitments from several local foundations and community groups have also made a significant contribution to the organisation's financial viability. We are extremely grateful to the Gwen and Edna Jones Foundation, the Ray & Joyce Uebergang Foundation, the Rotary Club of Warrnambool & the East Warrnambool Football and Netball Club for their multi-year investments in our community service and to the other foundations, community groups, businesses and individuals who have generously donated to Warrnambool & District Community Hospice. Thanks to strong support from the community, we have been able to achieve a net profit in 2023/24 of \$96,506 and grow cash reserves to \$1,032,030. This provides us with confidence that the organisation could, in the short term, withstand a loss or reduction in government support, or the impact of economic pressures on philanthropic giving.




Financial Report

Expenses

Warrnambool & District Community Hospice continues to be very mindful of its spending and focused on maximising the impact of the donated and granted funds it receives.

In 2023/24 78% of expenses were related to the employment of our staff, including wages, Superannuation, Workcover, professional development and leave liability. We feel that this level of expenditure is vital to maintain a high-performing paid workforce, with the skills and experience to effectively leverage a large volunteer workforce and maintain a high-quality service of value to the community.





Warrnambool & District Community Hospice was built upon the generosity of the community and the willingness of local people, businesses, and community groups to support our work. We take this opportunity to thank everyone who has supported us over the last year and contributed to the achievements outlined in this report. Our fundraising activities are not just about donations, they are also important avenues to build the profile of our organisation and connect with people who need our support.

Fundraising Activities & Events

We are extremely grateful to the community groups and organisations who provided opportunities for Warrnambool & District Community Hospice to raise funds while also promoting our free community services.

In July 2023, local theatre groups Warrnambool Theatre Company and Holiday Actors provided us with the opportunity to be the charity partner for their combined production of The Wizard of Oz at the Lighthouse Theatre in Warrnambool. We thank both companies for the chance to promote Hospice in the Home to their audience and raise \$480 through a tin rattle in the foyer prior to each performance.

For the second year, the Dennington Community Association directed gold coin donations collected on the gate at their popular Carols by the Merri event to Hospice. They also invited a group of our volunteers to perform the "Rudolph Hokey Pokey" and raised \$1350.

We were thrilled to be selected by the Warrnambool Racing Club as their Community Race Day Partner for 2024 as part of the JUMP Charity Partner Initiative. Thanks to Warrnambool Racing Club and our volunteer "tin rattlers" \$4751 was raised at the Community Race Day on the 12th of March 2024.

Our volunteers also rattled tins on the gate at the Warrnambool Greyhound Racing Club's 2024 Warrnambool Cup in May. We collected \$1192 in donations and wish to thank the Warrnambool Greyhound Racing Club for their ongoing support.

Thanks to the Rotary Club of Warrnambool Central, we raised \$1000 selling tickets for their Golden Community Raffle. If that was not exciting enough, it was even more exciting that someone within our Hospice community won first prize.

Grants

Warrnambool & District Community Hospice is very fortunate to be well-supported by local trusts and foundations. Grants

Hospice in the Home

The Peter's Project Foundation awarded a \$10,000 grant towards the operation of Hospice in the Home (paid in 2022/23 for the 2023/24 financial year). The grant forms part of the Peter's Project Foundation's ongoing commitment to the availability of cancer care services in South West Victoria. We are very grateful for the support of Peter's Project who, like Hospice, value maintaining connections to home and community.

After Hours Phone Service

The Uniting Church Distribution Fund generously granted a further \$5,397 (after gifting \$4,827 the previous year) to continue funding our Hospice in the Home After Hours Phone Service in 2023/24. The grant covers the cost of oncall allowances paid to our Support Coordinators so that they are available to be contacted on weekends and public holidays. This essential service ensures our volunteers, clients, and their carers are well supported when giving and receiving care out of business hours.

Audio Visual & Meeting Equipment

The Gardiner Dairy Foundation, through the FRRR provided a grant of \$4,855 for the purchase of a portable data projector, screen, laptop and whiteboard. This gives us greater flexibility in where we can deliver community education and volunteer training sessions, as well as improve the functionality of Hospice House as a meeting and training space.

Container Deposit Scheme

Registration as a charity with the Victorian Container Deposit Scheme in November 2023 saw \$258 raised from people electing Hospice to receive the proceeds from their container refunds.

Annual Appeal

The 2024 Annual Appeal raised funds to support our infection prevention measures and help stop the spread of COVID-19, Influenza and other infectious illnesses that may impact the wellbeing of our clients, their caregivers and volunteers. The appeal was sent via email and promoted on social media, raising a total of \$4,544. This money will be used to provide our volunteers with COVID-19 test kits, gloves, masks and hand sanitizer and infection prevention training and resources.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2024

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements cover Warrnambool & District Community Hospice Inc. as an individual entity, incorporated and domiciled in Australia. Warrnambool & District Community Hospice Inc. is an Incorporated Association.

The financial statements were authorised for issue by the Committee.

Financial Reporting Framework

The Committee has prepared the financial statements on the basis that the association is a non-reporting entity because there are no users dependant on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the Australian Charities and Not-for-profits Commission Act 2012. The Association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012 and the significant accounting policies disclosed below, which the Committee has determined are appropriate to meet the needs of members.

Statement of Compliance

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of the following Accounting Standards:

AASB 101: Presentation of Financial Statements;

AASB 107: Cash Flow Statements;

AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1031: Materiality;

AASB 1048: Interpretation of Standards;

AASB 1054: Australian Additional Disclosures;

Basis of Preparation

The Financial report, except for the cash flow information, has been prepared on an accrual basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non current assets. The amounts presented in the financial statements have been rounded to the nearest dollar.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2024

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES Accounting Policies

(a) Income Tax

The Association is exempt from the payment of tax under Section 50 of the Income Tax Assessment Act 1997.

(b) Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, less any accumulated depreciation and impairment losses.

Plant and equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses. The carrying amount of plant and equipment is reviewed annually by the Committee to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flow have been discounted to their present values in determining recoverable amounts.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of comprehensive income during the financial period in which they are incurred.

(c) Depreciation

Fixed assets are depreciated on a diminishing value basis over their useful lives to the economic entity commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

Plant and Equipment

20%-67%

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date. An asset's carrying amount is written down immediately to it's recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount. Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the statement of comprehensive income.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2024

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (cont.)

(d) Impairment of Assets

At each reporting date the Organisation reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value-in-use, is compared to the asset's carrying value. Any excess of the asset's carrying value over it's recoverable amount is expensed to the Statement of Comprehensive Income.

Where it is not possible to estimate the recoverable amount of an asset, the Organisation estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Where an impairment loss on a revalued asset is identified, this is debited against the revaluation surplus in respect of the same class of asset to the extend that the impairment loss does not exceed the amount in the revaluation surplus for that same class of asset.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short term highly liquid investments with original maturities of three months or less and bank overdrafts. Bank overdrafts are shown within borrowings of current liabilities on the Statement of Financial Position.

(f) Revenue

Revenue from the sale of goods is recognised upon the delivery of goods to the members or customers, Other income is recognised as revenue at the time the Organisation obtains control over the assets, this usually occurs upon receipt of the funds from the customer, fees and memberships received from members and sponsorship, fundraising and donations received from contributors. Interest revenue is recognised on a proportional basis taking into account the interest rate applicable to the financial asset. All revenue is stated net of the amount of GST.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables are shown inclusive of GST.

(i) Key Estimates

(i) Impairment

The Committee assesses impairment at the end of each reporting period by evaluating conditions and events specific to the Association that may be indicative of impairment triggers.

(ii) Plant & Equipment

As indicated in note 1(c), the Association reviews the useful life of plant and equipment on an annual basis.

(j) Employee Entitlements

Annual leave entitlements have been recorded in the Statement of Financial Position for the current 4 employees. Oncosts for superannuation, workcover and leave loading have been incorporated into the balance.

Provision for long service leave has been brought to account in the Statement of Financial Position for all 4 employees at 30/06/2024.

Report on the Audit of the Financial Report
