1. **1st prize award \$2,000. (Sponsored by Fletcher Jones Family Foundations)**
2. **2nd prize \$300. (Sponsored by Maddens Lawyers)**
3. **Highly commended prize awarded the Sponsors' Prize.**
4. Artwork's frame size from the outside edge must measure no larger than 105cms W x 105cms H x 10cms D. All entries must be dry, ready for display, framed and ready to hang with picture wire attached.
5. Artwork is to be labelled on the back with Title of artwork, Artist's Name and Phone Number.
6. Sculpture must be easily carried, freestanding, stable, secure and ready to display.
7. All artworks must be for sale at the price set by the artist including a 30% commission retained by Warrnambool and District Community Hospice at point of sale.
8. **Entries close on the 28th April 2025.**
9. Your artwork is to be delivered to the Warrnambool Racecourse Matilda Room **between 2PM and 5PM on Thursday 8th May 2025.**
10. The judging will take place on **Friday 9th May 2025.** Prize money and proceeds of the sale of your artwork will be paid by EFT the week commencing 19th May. You will be contacted by the Organising Committee to supply your bank account details for the transfer of prize money or payment for artwork sold.
11. Unsold artwork must be collected from the Matilda room **between 10AM and 1PM on Thursday 15th May 2025.**

12. **Artwork entry fee is \$10 per item.** Fees must be received by the Organising Committee by the closing date and can be paid by EFT to:
